Qualification Awarded

Graduate Diploma with Thesis is awarded to students who graduate from this program.

Level of Qualification

Students who successfully complete this program are awarded a Master''s Degree with Thesis in their field.

Specific Admission Requirements

In order to apply for a master'''s program with thesis, candidates must: Students are required to get at least 55 points from the related branch of the Academic Personnel and Postgraduate Education Entrance Exam (ALES) with the undergraduate diploma obtained from the departments specified in the student admission conditions. There is no foreign language requirement in the Basic Islamic Sciences Master''s Program with Thesis.

Specific Arrangements for Recognation of Prior Learning

Candidates can be exempted from some courses according to Kayseri University Postgraduate Education and Training Regulation. Based on certain principles, courses previously taken from another educational institution are exempted from graduation credits if the learning outcomes of the courses comply with the program.

Qualification Requirements and Regulations

Master''s degree 2.-4. pass all the courses in the program (120 ECTS) in the semester and 4th-6th. It is given to students who successfully defend their thesis in the second term.

Profile of the Program

In order to apply for a master''s program with thesis, candidates must: Students are required to get at least 55 points from the related branch of the Academic Personnel and Postgraduate Education Entrance Exam (ALES) with the undergraduate diploma obtained from the departments specified in the student admission conditions. There is no foreign language requirement in the Basic Islamic Sciences Master''s Program with Thesis. The duration of education is limited to four / six semesters regardless of the time spent in scientific preparation, starting from the semester in which the courses related to the Basic Islamic Sciences program are given, regardless of whether they have registered for each semester. The Department of Basic Islamic Sciences consists of Hadith, Tafsir, Kalam and History of Islamic Sects, Sufism, Arabic Language and Rhetoric and Islamic Law. The aim of the Basic Islamic Sciences Master''s Program with Thesis is to train skilled and skilled researchers with critical thinking skills who will be able to produce and share knowledge in relevant disciplines at national and international level. To prepare students who are successful at the Master''s level for the PhD stage.

1- In addition to their undergraduate competencies, the student develops and deepens the knowledge in Basic Islamic Sciences at the expert level.
